1. WARRANTY COVERAGE

Niklyn hereby warrants that the Coatings identified in section 9.0 of this warranty shall not:

- 1.1. Check, crack, blister or delaminate from the substrate.
- 1.2. Change color more than 5 DE Hunter units as determined in accordance with ASTM D 2244 by comparing the affected exposed coating cleaned with water and a soft cloth with unexposed Original Project Color Standards (see Item 3.2 below) maintained by Niklyn and the Owner.
- 1.3. Exhibit loss of gloss in excess of 24 units as measured by a gloss meter in accordance with ASTM D523-89 with 60-degree geometry.
- 1.4. Chalk in excess of a rating 8 as measured in accordance with ASTM D4214, Method A.

2. LENGTH OF COVERAGE

Warranty coverage shall be effective for a period of five (5) years beginning on the substantial completion date identified in section 8.0 of this warranty or beginning six (6) months following commencement of painting, whichever comes first.

3. CONDITIONS

This warranty is contingent upon the following conditions:

- 3.1. Coverage under this warranty is contingent upon formal Owner acceptance by signature prior to completion of project.
- 3.2. In the event of a claim against this warranty, Niklyn shall have the right to perform such inspections and/or test of the coated structure as Niklyn deems necessary to determine whether a Coatings failure is covered by the warranty described above.

- 3.4. The results of all tests identified in Section 1.0 above shall be the average of three (3) readings taken from each affected area
- 3.5. The coated Metal must be a surface on which no standing water accumulates.
- 3.6. The warranty for any refinished or replaced metal substrate shall be only for the remainder of the original warranty period applicable to the original coated metal substrate.
- 3.7. This Agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Connecticut, United States of America without giving effect to any choice of conflict of law provision or rule that would cause the application of the law of the jurisdiction other than Connecticut. The Owner hereby consents to the jurisdiction of, and hereby waives any defenses based on lack of jurisdiction or venue by, the Commonwealth of Connecticut, New Haven County, for all purposes and proceedings related to any dispute related to or arising out of this Agreement
- 3.8. Niklyn must receive full and timely payment of all Niklyn invoices related to this project.

4. EXCLUSIONS

This warranty does not cover any failure resulting from or related to:

- 4.1. Niklyn Crevice corrosion and resultant rust staining of adjacent painted surfaces from areas inaccessible for proper surface preparation and coating application through normal paint practices including, but not limited to uncaulked back-to-back angles, substrate overlaps, bolted and/or riveted connections, seams, skip-welds, etc.
- 4.2. Exposure to heat in excess of normal ambient exterior temperatures.
- 4.3. Harmful chemicals, fumes or vapors, unless specifically agreed upon by Niklyn in writing.
- 4.4. Vandalism or physical abuse
- 4.5. Negligence or lack of proper maintenance and repair of coated structure
- 4.6. Any acts or omission of contractor.
- 4.7. Significant change in the use of coated structure.
- 4.8. Failure of repairs to coatings made by others or non-certified contractors.

5. SITUATIONS NOT WARRANTED

In addition to the exclusions above, this warranty is subject to force majeure and is contingent upon acts which are beyond the reasonable control of the party from which performance is required, including, but not limited to fire, flood, earthquake, tornado, damaging hail, lightning strike or other Acts of God; acts of war, riot, explosion, terrorist activity or other catastrophic events.
